RESOLUTION OF THE BOARD OF SUPERVISORS DECLARING ACCEPTANCE OF THE REQUIREMENTS OF SECTIONS 13510, 13512, AND 13522 OF THE CALIFORNIA PENAL CODE RELATING TO THE RECRUITMENT AND TRAINING OF PEACE OFFICERS

On Tuesday December 17, 2019, on motion of Supervisor Lovingood, duly seconded by Supervisor Gonzales and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the County of San Bernardino, Human Services Program Integrity Division conducts welfare fraud investigations and desires to administer a Peace Officer Standards and Training certification program that will provide continual professional growth and development of fraud investigator personnel to ensure they possess the knowledge and skills necessary to provide a professional level of service meeting the needs of the County and community; and

WHEREAS, the Commission on Peace Officer Standards and Training was established pursuant to the State of California under the provisions of Section 13500 through 13533, Chapter 1 of Title 4, Part 4 of the California Penal Code to provide oversight for the standards and training of local law enforcement and administration of the California Peace Officer Standards and Training Program; and

WHEREAS, the County of San Bernardino, Human Services Program Integrity Division desires to participate in the Peace Officer Standards and Training Program per the State of California under the provisions of Section 13522, Chapter 1 of Title 4, Part 4 of the California Penal Code; and

WHEREAS, Pursuant to Sections 13510 and 13512 of said Chapter 1, the County of San Bernardino, Human Services Program Integrity Division will adhere to the standards for recruitment and training established by the Commission on Peace Officer Standards and Training.

NOW, THEREFORE BE IT RESOLVED, the County of San Bernardino, Board of Supervisors declares its acceptance of the requirements of sections 13510, 13512, and 13522 of the California Penal code relating to the recruitment and training of peace officers, per the Commission on Peace Officer Standards and Training.
