#### AMENDMENT NO. 3

It is hereby agreed to amend Contract No. 17-301, effective March 1, 2020, as follows:

## **SECTION V. FISCAL PROVISIONS**

Amend Section V, Paragraph A, to read as follows:

A. The maximum amount of payment under this Contract shall not exceed \$750,000, of which \$750,000 may be federally funded, and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem. It includes the original contract amount and all subsequent amendments and is broken down as follows:

#### **SECTION VIII. TERM**

Amend Section VIII. to read as follows:

This Contract is effective as of June 1, 2017 and is being extended from its amended expiration date of February 29, 2020, to a new amended expiration date of February 28, 2021, but may be terminated earlier in accordance with provisions of Section IX of the Contract. The contract term may be extended for one (1) additional one-year period by mutual agreement of the parties.
