1 (c) Any additional equipment or supplies necessary to carry out Election
2 Worker duties on Election Day will be provided by the Registrar of Voters. The
3 Registrar of Voters will keep affected department heads informed of employees who
4 volunteer for service on Election Day in terms of their attendance.

5 (d) The Registrar of Voters will reimburse each employee's department for the
6 compensation the employee receives while in election worker training. Regardless of
7 whether the hours worked as an Election Worker on or before Election Day count as
8 overtime, the Registrar of Voters will reimburse an employee's department for any
9 weekly overtime that the department is liable for due to the employee working as an
10 Election Worker on Election Day.

11 (e) This section shall remain in effect until January 16, 2025, and as of that
12 date is repealed, unless a later ordinance that is enacted and effective before January
13 16, 2025, deletes or extends that date.

15 SECTION 2. This ordinance shall take effect 30 days from the date of adoption.
