**AMENDMENT NO. 2:**

It is hereby agreed to amend Contract No. 16-327, effective July 1, 2020, as follows:

**SECTION V. FISCAL PROVISIONS**

**Amend Paragraph A to read as follows:**

- A. The maximum amount of payment under this Contract shall not exceed \$46,275,100, and shall be subject to availability of funds to the County. The consideration to be paid to the Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

**SECTION VIII. TERM**

**Amend Section to read as follows:**

This Contract is effective as of July 1, 2016 and is extended from its expiration date of June 30, 2020 to expire on June 30, 2021, but may be terminated in accordance with the provisions of Section IX of the Contract.

All other terms and conditions of Contract No. 16-327 remain in full force and effect.
