Ordinance No. 4382

An ordinance of the County of San Bernardino, State of California, adding Chapter 22 to Division 3 of Title 6 of the San Bernardino County Code, relating to adoption of the Model Water Efficient Landscape Ordinance.

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. Chapter 22 is added to Division 3 of Title 6 of the San Bernardino County Code, to read:

CHAPTER 22: MODEL WATER EFFICIENT LANDSCAPE ORDINANCE

The Model Water Efficient Landscape Ordinance (Sections 490 through 495 of Chapter 2.7 of Division 2 of Title 23 of the California Code of Regulations), which may be referred to in the County Code as the MWELO, as promulgated by the California Department of Water Resources, as may be amended, is hereby adopted and incorporated by reference into the County Code. One copy of the MWELO shall be on file and available for use by the public in the Office of the Clerk of the Board of Supervisors of the County of San Bernardino.

SECTION 2. This ordinance shall take effect thirty (30) days from the date of adoption.
