### RESOLUTION DECLARING QUALIFIED NOMINEES ELECTED TO SAN BERNARDINO COUNTY CENTRAL COMMITTEES FOR THE MARCH 3, 2020 PRESIDENTIAL PRIMARY ELECTION

On Tuesday April 07, 2020, on motion of Supervisor Lovingood, duly seconded by Supervisor Gonzales and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.
