# IT IS HEREBY AGREED AS FOLLOWS:

### **AMENDMENT NO. 1 TO CONTRACT 18-546**

WHEREAS, the San Bernardino County Flood Control District (District) and BNSF Railway Company (BNSF) (collectively, "Parties") entered into Contract Agreement No. 18-546 (also referenced as Agreement No. BF-10012758) on July 24, 2018, (Contract) for the delivery of structural engineering services for the West Fontana Channel Flood Control Improvement Project (Project).

**WHEREAS**, Exhibit C of the Contract sets forth the roles and responsibilities of each agency as related to Project construction.

WHEREAS, pursuant to the Contract, BNSF shall serve as lead agency in the construction of the railroad work; procurement of materials, equipment, supplies, preliminary engineering, design, and contract preparation for the removal and replacement of 240 feet of the Muskat Lead, Track No. 3; relocation of five (5) Kaiser Yard Light Poles; and provide a flagman, as well as provide inspection as required in connection with the construction of

the Project; and provide a contract project coordinator, at the District's expense to serve as a project manager for the railroad related work.

**WHEREAS**, the Contract requires the District to pay BNSF the sum of \$2,000 for an Administrative Fee and the sum of \$4,072 for a "Temporary Construction License Fee" as well as the estimated project cost of \$525,767 for furnished labor, materials, tools, and equipment for railroad work needed for the construction on the Project. The Contract also included a 20% contingency for unforeseen errors, omissions, and changes during the construction of the Project.

WHEREAS, since the execution of the Contract, the Parties desire to amend the Contract in order for BNSF to provide additional construction support services, as required by both the BNSF Railroad Company and the Federal Railroad Administration (FRA) Safety Guidelines & Regulations during the construction phase of the Project; and

**WHEREAS**, the Parties desire to further expand the scope of services for the Project construction phase and, correspondingly, increase the contract amount for such additional work.

**NOW THEREFORE**, in consideration of mutual covenants and conditions, the Parties agree as follows:

1. Exhibit "D" to the Contract is hereby deleted and replaced with the following:
