


COVID-19 Positive & Suspected



SB County Hospital COVID-19 Census




SB County Projected Hospital COVID Census





State of California Phase 2 Reopening Standards

*County openings dependent on state guidelines to be shared on Thursday, 5/7. All information below obtained from Governor Newsom's press release on 5/4.

Early Phase 2 (starting Friday)

Opening of some retail, manufacturing, and logistics businesses that comply with all modifications that lower the risk of transmission, including curbside pick-up.

Early Phase 2 openings Include (as examples):

Bookstores Clothing stores Florists Sporting goods stores

Early Phase 2 openings don't include (as examples):

Offices (can telework) Seated dining at restaurants Shopping malls





Timeline to move through Phase 2 and into Phase 3

*All information below obtained from Governor Newsom's press release on 5/4.

- The timeline for how quickly we move through Phase 2 is up to us
- Counties have the ability to move more quickly through Stage 2 if we meet the state's readiness criteria via the creation of a County readiness plan






