

RESOLUTION NO. 2020-86

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF ZONE A OF COUNTY SERVICE AREA 68, (VALLEY OF THE MOON) FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2020-21

On Tuesday June 2, 2020, on motion of Supervisor Rowe, duly seconded by Supervisor Lovingood and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of Zone A of County Service Area 68, therefore, hereby finds and determines:

(a) That on August 8, 2017, the electors of Zone A of County Service Area 68, duly authorized a special tax levy for road maintenance services.

(b) That the amount of such tax shall not exceed \$147 per parcel for the first year with an annual inflationary factor of up to 2.5%, per year for five years, and \$117 per parcel each year thereafter with an annual inflationary factor of up to 2.5% every year thereafter.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of Zone A of County Service Area 68, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2020-21 shall be set at \$158.31 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective July 1, 2020.
