

RESOLUTION NO. 2020-85

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 59 (DEER LODGE PARK), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2020-21

On Tuesday June 2, 2020, on motion of Supervisor Rowe, duly seconded by Supervisor Lovingood and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of County Service Area 59, therefore, hereby finds and determines:

(a) That on June 7, 2011, the electors of County Service Area 59, duly authorized a special tax levy for road paving and road maintenance services.

(b) That the amount of such tax shall be a first year special tax of \$220 per parcel per parcel with a 2.5% inflationary factor increase each year thereafter.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of County Service Area 59, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2020-21 shall be set at \$274.75 per parcel, which includes the annual inflationary factor increase of 2.5%.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective July 1, 2020.
