## Ordinance No. 4382

An ordinance of the County of San Bernardino, State of California, adding Chapter 22 to Division 3 of Title 6 of the San Bernardino County Code, relating to adoption of the Model Water Efficient Landscape Ordinance.

One copy of the MWELO shall be on file and available for use by the public in the Office of the Clerk of the Board of Supervisors of the County of San Bernardino.
