

## **RESOLUTION NO. 2020-129**

### **RESOLUTION OF THE BOARD OF DIRECTORS OF SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT TO APPROVE A REQUEST FOR TEMPORARY TRANSFER OF FUNDS**

On Tuesday, June 23, 2020, on motion of Director Gonzales, duly seconded by Director Lovingood and carried, the following resolution is adopted by the Board of Directors of the San Bernardino County Fire Protection District.

WHEREAS, the San Bernardino County Treasurer does not have the authority to honor warrants drawn on San Bernardino County Fire Protection District funds with insufficient cash balances; and

WHEREAS, the Board of Directors of San Bernardino County Fire Protection District may request from the San Bernardino County Auditor-Controller/Treasurer/Tax Collector a temporary transfer of funds from the County, which is required by law to make the temporary transfer of funds if it has monies available that are not immediately needed for its own use; and

WHEREAS, temporary transfer of funds will be made from July 1, 2020, up to the date of the first property tax apportionment occurring after November 1, 2020; and

WHEREAS, repayment of half of the temporary transfer of funds will be on December 27, 2020, and the final half on April 26, 2021; and

WHEREAS, interest shall be charged to the San Bernardino County Fire Protection District at the Treasurer's Investment Pool rate.

NOW, THEREFORE BE IT RESOLVED, the Board of Directors of the San Bernardino County Fire Protection District hereby finds, determines, declares, and resolves as follows:

Section 1. The Board of Directors of the San Bernardino County Fire Protection District hereby requests a temporary transfer of funds to be deposited in the following amounts and to be repaid as provided in the above recitals: \$4,414,204 for the Mountain Regional Service Zone (2448); \$9,183,431 for the North Desert Regional Service Zone (2442); \$5,666,911 for the South Desert Regional Service Zone (2454); \$29,237,475 for the Valley Regional Service Zone (2434) and \$8,902,620 for the San Bernardino County Fire Protection District (2410), for a total amount of \$57,404,641 for the Fiscal Year 2020-21 by the San Bernardino County Auditor-Controller/Treasurer/Tax Collector.
