## RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO TO ESTABLISH A NO STOPPING, STANDING OR PARKING ZONE ON STANFIELD CUTOFF, BIG BEAR AREA

On Tuesday June 23, 2020, on motion of Supervisor Gonzales, duly seconded by Supervisor Lovingood and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

Due to conditions affecting the welfare of the public utilizing Stanfield Cutoff (771150) in the Big Bear area, the Board of Supervisors, pursuant to an engineering and traffic survey, deems it necessary to:

1. Due to conditions affecting the welfare of the public utilizing Stanfield Cutoff in the Big Bear area, the Board of Supervisors, pursuant to a traffic engineering investigation deems it necessary and hereby resolves to:

Establish a "No Stopping, Standing or Parking" zone pursuant to County Code section 52.0118 on Stanfield Cutoff in the Big Bear Area, along the west side from approximately 753 feet south of North Shore Drive to approximately 1,930 feet south of North Shore Drive for a total distance of approximately 1,177 feet and on the east side from approximately 1,200 feet south of North Shore Drive to approximately 1,460 feet south of North Shore Drive for a total distance of 260 feet in the Big Bear area.

2. The County Road Commissioner is hereby directed to perform such acts as are necessary to establish the "No Stopping, Standing or Parking" zones on Stanfield Cutoff (771150) for the reaches identified herein, in the Big Bear area.
