EIGHTH AMENDMENT

Contract No. 14-110 to provide supplemental law enforcement services to LIVE NATION is hereby amended, effective July 1, 2020, as follow:

- (3) To replace the first sentence in **Section III** in its entirety with:
 - III. This contract shall be for a period of time commencing on March 1, 2014 through June 30, 2021

- (4) To replace **Sections IV.A.1** and **IV.A.2** in their entirety with:
 - IV.A.1 LIVE NATION agrees to indemnify, defend (with counsel reasonably approved by the COUNTY) and hold harmless the COUNTY and its authorized officers, employees, agents and volunteers ("Indemnitees"), from any and all claims actions, losses, damages, and/or liability arising out of this contract from any cause whatsoever, including the acts, errors or omissions of any person and for any costs or expenses incurred by the COUNTY on account of any claim except where such indemnification is prohibited by law. This indemnification provision shall apply regardless of the existence or degree of fault of Indemnitees. LIVE NATION shall furnish Certificates of Insurance to the SHERIFF evidencing the insurance coverage at the time the contract, or annual amendments, are executed, additional endorsements, as required shall be provided prior to the commencement of performance of services hereunder, which certificates shall provide that such insurance shall not be terminated or expire without thirty (30) days written notice to the SHERIFF, and LIVE NATION shall maintain such insurance from the time LIVE NATION commences performance of services hereunder until the completion of such services. Within fifteen (15) days of the commencement of this contract, or annual amendments, LIVE NATION shall furnish a copy of the Declaration page for all applicable policies and will provide complete certified copies of the policies and endorsements immediately upon request.
