THIS CONTRACT is entered into in the State of California by and between the County of San Bernardino, hereinafter called the County, and Inland Behavioral and Health Services, Inc. referenced above, hereinafter called Contractor.

IT IS HEREBY AGREED AS FOLLOWS:

WITNESSETH:

IN THAT CERTAIN **Contract No. 16-410** by and between the County of San Bernardino, a political subdivision of the State of California, and Contractor provision of Substance Use Disorder Recovery Services Perinatal Services, which Contract first became effective July 1, 2016 the following changes are hereby made and agreed to, effective July 1, 2020:

- I. ARTICLE IV <u>Funding</u> paragraph K is hereby amended to read as follows:
 - K. The maximum financial obligation under this contract shall not exceed \$640,225 per fiscal year for term of this contract. This amendment shall increase the total contract amount from \$2,560,900 to \$3,201,125. All previously approved Budget Schedules remain in effect. The Schedules A and B for fiscal year 2020-21 will be submitted to, and approved by, the Director or designee at a later date.
- II. ARTICLE XV <u>DURATION AND TERMINATION</u> paragraph A is hereby amended to read as follows:
 - A. The term of this Agreement shall be from July 1, 2016 through June 30, 2021 inclusive.

III. All other terms, conditions and covenants in the basic agreement remain in full force and effect.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
