FOURTH AMENDMENT TO COOPERATIVE AGREEMENT NO. 00-1086

IT IS HEREBY AGREED AS FOLLOWS:

WITNESSETH

WHEREAS, the San Bernardino County Flood Control District (**DISTRICT**) and the Chino Basin Water Conservation District (**CBWCD**) entered into Cooperative Agreement No 00-1086 (Agreement) to cooperate and facilitate the construction of proposed flood control and water conservation improvements on the outlet of the existing Grove Avenue Detention Basin, in the City of Ontario, and

WHEREAS, pursuant to Section 16 of the Mutual Agreements section of the Agreement, the term of the Agreement is for five years from the execution date of October 24, 2000, but the parties may extend the Agreement for additional five (5) terms, up to six (6) times, and

WHEREAS, the DISTRICT and CBWCD previously executed three amendments to the Agreement to extend the term of the Agreement in five year increments per amendment, through October 24, 2020, and

WHEREAS, the **DISTRICT** and **CBWCD** desire to amend the Agreement to exercise their fourth option to extend the term of the Agreement by an additional five years, through October 24, 2025.

NOW, THERFORE, in consideration of the mutual covenants and conditions set forth herein, the parties hereto agree to amend Cooperative Agreement, Contract No. 00-1086, as follows:

- 1. Section 16 of the Mutual Agreements section of the agreement is hereby deleted and replaced with the following:
 - 16) The term of this Contract is for twenty-five (25) years from the execution date, unless terminated as hereinafter specified. The **DISTRICT** will consider approval of five (5) year time extensions upon written request from the **CBWCD** one (1) year prior to the expiration of the term and any extensions thereto. Approval by the **DISTRICT** of said extensions shall be subject to review as to the current fiscal environment and the **DISTRICT's** current land use needs at that time. Said approval of subject five (5) year time extensions will not be unreasonably withheld. A total of two (2) time extensions will be allowed.
- 2. All other provisions and terms of the Agreement shall remain unchanged. In the event of any conflict between the Agreement, as previously amended, and this Fourth Amendment, the provisions and terms of the Fourth Amendment shall control.
