<u>COUNTY AND CHIEF EXECUTIVE OFFICER GOALS & OBJECTIVES</u> Provide for the Safety, Health and Social Service Needs of County Residents.

FINANCIAL IMPACT

The action to continue this local emergency will not require the use of additional Discretionary General Funding (Net County Cost).

BACKGROUND INFORMATION

On March 10, 2020, in accordance with Government Code section 8630(a), the Chairman of the Board of Supervisors (Board) proclaimed the existence of a local emergency for COVID-19 affecting all cities/communities in San Bernardino County. The impacts from COVID-19 resulted in the need for the County to implement emergency protective measures.

Pursuant to Government Code section 8630(C), the Board shall review the need for continuing the local emergency at least once every 60 days until such emergency is terminated. Board approval of this recommendation would continue the local emergency for an additional period in accordance with Government Code section 8630(c). The Board last took action to continue this local emergency on July 28, 2020 (Item No. 31).
