

**RESOLUTION NO. 2020-182**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF THE COUNTY OF SAN BERNARDINO TO  
ESTABLISH AND REMOVE TRUCK RESTRICTIONS ON CACTUS AVENUE  
AND JURUPA AVENUE, BLOOMINGTON AREA**

On Tuesday October 6, 2020, on motion of Supervisor Hagman, duly seconded by Supervisor Lovingood and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, the Department of Public Works determined a need to establish commercial truck restrictions on Cactus Avenue, in the Bloomington area; and,

**WHEREAS**, the Department of Public Works determined a need to rescind commercial truck restrictions on Jurupa Avenue, in the Bloomington area; and,

**WHEREAS**, the Board of Supervisors is authorized to establish "No Trucks over 5 Tons" zone restrictions on County roads; and,

**WHEREAS**, the Board of Supervisors desires to establish commercial truck restrictions on Cactus Avenue; and,

**WHEREAS**, the Board of Supervisors desires to rescind commercial truck restrictions on Jurupa Avenue.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting residents on Cactus Avenue (197400) in the Bloomington area, the Board of Supervisors, pursuant to the determination of Traffic Division deems it necessary and hereby resolves to:

Establish a "No Trucks Over 5 Tons" zone pursuant to County Code Section 52.0131 along Cactus Avenue from Jurupa Avenue to Santa Ana Avenue, in the Bloomington area.

Rescind Resolution 2010-17 of "No Trucks Over 5 Tons" zone pursuant to County Code Section 52.0131 along Jurupa Avenue (455900) from Cactus Avenue easterly to Rialto City Limit, in the Bloomington area.

2. The County Road Commissioner is hereby directed to perform such acts as are necessary to:

Establish the Truck Restriction above on Cactus Avenue (197400), in the Bloomington area.

Rescind the Truck Restriction above on Jurupa Avenue (455900), in the Bloomington area.
