WHEREAS, The County of San Bernardino and Contractor desire to amend and modify the Agreement as follows:

Amendment No. 1 is a change in the name and taxpayer identification number, from Oracle Investigations Group, Inc. 80-0523883 to Oracle Investigations Group, LLC 85-2216077.

The parties further agree that the Contractor will assume and perform all responsibilities, obligations and duties under Contract No. 20-233 and this Amendment.

Except as amended herein, no other section of the Agreement is amended and all other terms and conditions remain the same.

WHEREAS, The County of San Bernardino and Contractor are currently complying with shelter at home orders due to Covid-19, this agreement may be executed in any number of counterparts, each of which so executed shall be deemed an original, and such counterparts shall together constitute one and the same Agreement.
