The County of San Bernardino, within the unincorporated community of Phelan, proposes to widen four intersections on Phelan Road to accommodate left and right turn pockets at Sonora Rd., Tumbleweed Rd., Sunny Vista Rd. and Arrowhead Rd. Construction will consist of mill and overlay of existing pavement and widening with new pavement to accommodate pavement transitions. Work includes the construction of approach aprons, new pavement returns at intersecting streets and minor shoulder grading. The project is needed to improve access to intersecting streets. The project is needed to improve and enhance turning movements, increase safety and traffic circulation. All construction will be within agency R/W.

CR-2: In the event that human remains are found, the county coroner shall be notified and ALL construction activities within 60 feet of the discovery shall stop. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD).
