SECOND AMENDMENT

Assignment and Consent to Assignment

The Second Amendment to Contract Number 16-376 ("Assignment and Consent") is made and entered into, by and among the Board Governed County Service Areas, Big Bear Valley Recreation and Park District and Bloomington Recreation and Park District, (hereinafter called the "District") Hidden Valley Pump Systems, Inc. ("Assignor") and Brax Company, Inc. ("Assignee").

1. Assignor and Assignee hereby agree that the Assignor shall assign all its right, title, and interest, and delegate all its obligations, responsibilities and duties, in and to the Contract Number 16-376 ("Contract"), to Assignee as of January 5, 2021.
2. Assignee hereby accepts the assignment of all of Assignor's obligations responsibilities and duties under the Contract and all of Assignor's right, title, and interest in and to the Contract.
3. The District, pursuant to Section V(A)(7) of the Contract, hereby consents to the assignment by Assignor to the Assignee.

The District, in executing its consent to this Assignment and Consent, does not release Assignor from any claims or remedies it may have against Assignor under the Contract for obligations incurred prior to the effective date of the assignment.

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party

providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.
