## **BACKGROUND INFORMATION**

On March 10, 2020, in accordance with Government Code section 8630(a), the Chairman of the Board of Supervisors (Board) proclaimed the existence of a local emergency for COVID-19 affecting all cities/communities in San Bernardino County. The impacts from COVID-19 resulted in the need for the County to implement emergency protective measures.

Pursuant to Government Code section 8630(c), the Board shall review the need for continuing the local emergency at least once every 60 days until the Board terminates the local emergency. Board approval of this recommendation would continue the local emergency for an additional period in accordance with Government Code section 8630(c). The Board last took action to continue this local emergency on December 15, 2020 (Item No. 32).
