AMENDMENT NO. 2

On or before each anniversary of each year of the Term, Licensee shall report to CA at <u>MWPUSAGE@ca.com</u> in writing the aggregate MSU capacity at each Licensee location as at the anniversary date during the preceding twelve month period, listing by manufacturer, model, operating system, serial number and Licensee location each computer that is included within the MSU Capacity (as defined above). CA may request any additional usage and deployment information from Licensee in relation to such computers, and reserves the right, upon advance written notice, to conduct an audit of Licensee's usage directly, or through a mutually agreeable third party. If the Licensed MSUs has been exceeded, Customer agrees to pay CA, or CA's Authorized Reseller as chosen by Customer, as applicable, any applicable fees due for the preceding twelve-month period. Customer will, at CA's request upon reasonable notice, provide any further information as CA may reasonably require to verify the accuracy of the report.

- 2. Full Force and Effect. The Agreement, as amended by this Amendment, remains in full force and effect.
- 3. Capitalized Terms. Any capitalized term used but not defined in this Amendment shall have the meaning given to it in the Agreement or the Addendum, as applicable.
- 4. Counterparts. This Amendment may be signed in one or more counterparts, each of which shall be deemed an original but all of which taken together shall constitute one and the same instrument. A facsimile or e-mail transmission of a signed version of this Amendment shall be legal and binding on all parties.

The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
