





NOTES:

1. LOCATE ALL EXISTING UTILITIES IN AREA TO BE EXCAVATED PRIOR TO MOBILIZATION OF EQUIPMENT TO SITE; SUBMIT FIELD NOTES AND WRITTEN CONFIRMATION TO OWNER THAT WORK CAN PROCEED WITHOUT INTERFERENCE.
2. PROTECT ALL UTILITIES AND FACILITIES TO REMAIN.
3. CONTRACTOR TO ADJUST EXISTING SANITARY SEWER MANHOLES, ELECTRICAL MANHOLES, FIRE HYDRANTS, VALVE BOXES, WATER METERS, STORM MANHOLES ETC. TO MATCH PROPOSED FINISHED GRADES, IF NECESSARY.
4. MAXIMUM SLOPE SHALL BE 3:1 IN NON-PAVED AREAS.
5. CONTRACTOR TO REESTABLISH POWER TO RELOCATED LIGHT POLE.
6. SECTION CUTS FOUND ON C-05.

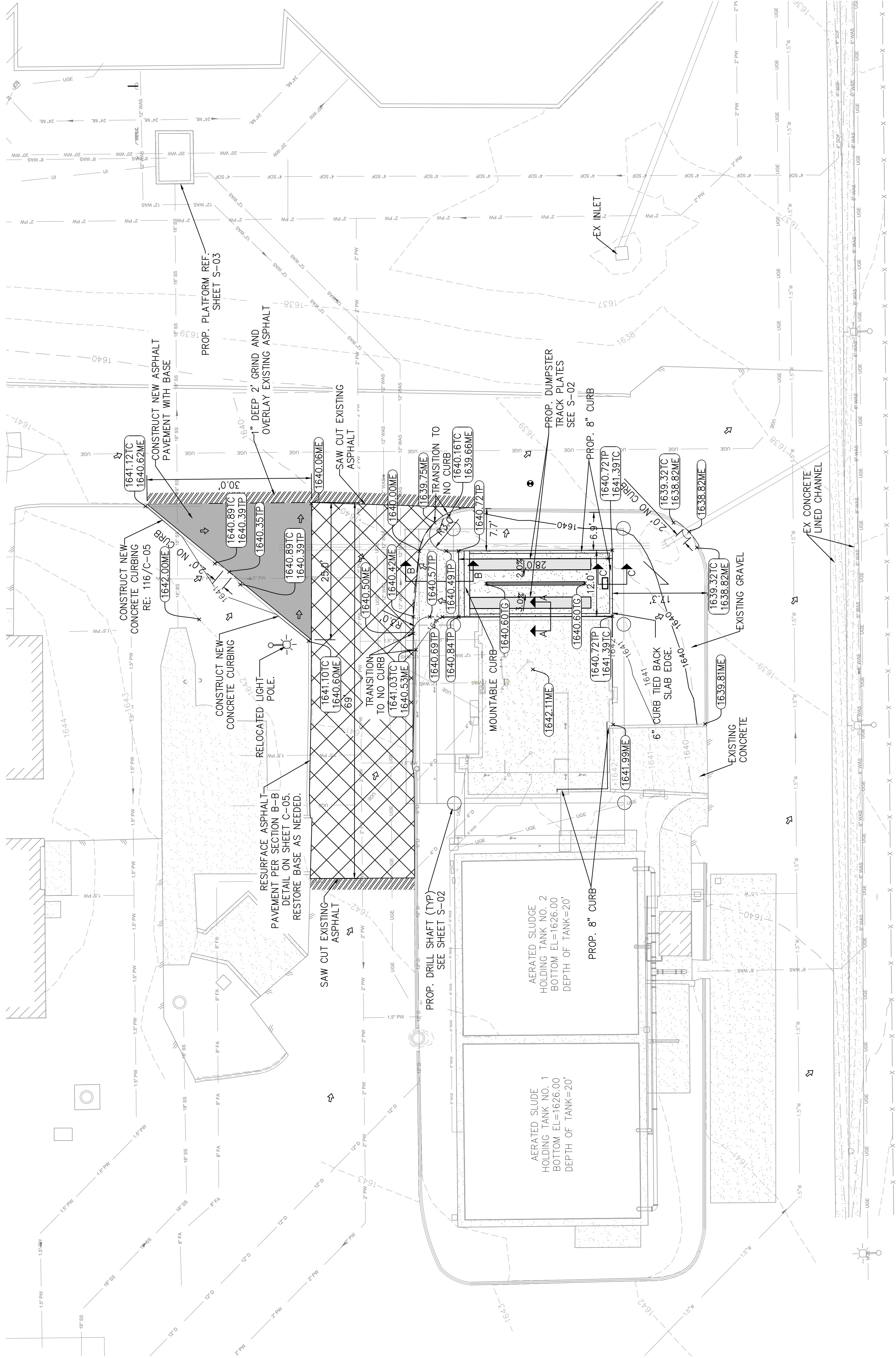
