2	An ordinance of the San Bernardino County Fire Protection
3	District establishing fire service fees, fire suppression, emergency response and cost recovery fees, ambulance
4	service and subscription fees, and repealing Ordinance No. FPD 20-02.

6	The Board of Directors of the San Bernardino County Fire Protection District,
7	County of San Bernardino, State of California, ordains as follows:
8 9	
9 10	SECTION 1. The Board of Directors of the San Bernardino County Fire
10	Protection District hereby finds and determines that:
12	(a) From and after the effective date of this ordinance, it shall be in full force
13	and effect within the San Bernardino County Fire Protection District.
14	(b) Due to budgetary limitations and constraints, it is necessary to continue
15	a uniform procedure and cost schedule to recover certain fire suppression and
16	emergency response costs and to continue providing a minimum level of fire
17	suppression and emergency response to areas within the San Bernardino County Fire Protection District within San Bernardino County.
18	(c) The recovery of such costs is authorized under <u>State law, including, but</u>
19	not limited to, the following statutes:
20	(1) Health and Safety Code sections 13007-13009.1, 13916, and
21	25270 et seq.;
22	(2) Government Code section <u>s</u> 53150 et seq. <u>, 68096.1, and 68097.2</u> ;
23	and
24	(3) Evidence Code section 1563.
25	(d) Such costs do not exceed the estimated actual cost of providing fire
26	suppression and emergency response.
27	(e) The collection and recovery of such costs is for the purpose of meeting
28	the necessary operating expenses of the responding service areas and the adoption

1	of the said fees is exempt from the provisions of the California Environmental Quality
2	Act.
3	
4	SECTION 2. There are hereby established and levied fire service fees, fire
5	suppression, emergency response and cost recovery fees, ambulance service and
6	subscription fees as set forth in Attachment A to this ordinance. The fees set forth in
7	Attachment A are effective July 1, 20201.
8	
9	SECTION 3. Effective July 1, 20201, Ordinance No. FPD 1920-012 is hereby
10	repealed in its entirety.
11	
12	SECTION 4. This ordinance shall be effective thirty (30) days from the date of
13	adoption.
