**RESOLUTION OF THE BOARD OF SUPERVISORS FOR THE APPROVAL OF THE PUBLIC
AUTHORITY AND NON-PROFIT CONSORTIUM RATE CHANGE REQUEST TO THE CALIFORNIA
DEPARTMENT OF SOCIAL SERVICES FOR IN-HOME SUPPORTIVE SERVICES PROVIDER
WAGES**

On Tuesday May 4, 2021, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Cook and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the In-Home Supportive Services (IHSS) Public Authority was established by the County of San Bernardino through Ordinance No. 3842 to act as the employer for San Bernardino IHSS providers pursuant to Welfare and Institutions Code section 12301.6, subdivision (c)(1), and to perform other IHSS functions as required by Welfare and Institutions Code section 12301.6, subdivision (e) and not retained by the County.

WHEREAS, pursuant to California Department of Social Services (CDSS) All County Letter No. I-67-20 issued March 11, 2021, Non-Health Benefits are to be claimed under the Services Category effective July 1, 2021. IHSS Public Authority must submit a Public Authority and Non-Profit Consortium Rate Change Request (SOC 449) establishing a Non-Health Benefits rate to be compliant with the new claiming process and to receive reimbursement of approved expenditures.

WHEREAS, CDSS requires the County of San Bernardino, Board of Supervisors to approve IHSS Public Authority's Public Authority and Non-Profit Consortium Rate Change Request (SOC 449) updating the Public Authority and Non-Profit Consortium rate pertaining to wages and benefits, for a total net decrease of \$0.04 per hour, from to \$16.15 per hour to \$16.11 per hour, effective July 1, 2021, updating the rate components specified below:

- a. Non-Health Benefits to be established at \$0.01 per hour.
- b. Administrative Rate decrease of \$0.05 per hour, from \$0.13 per hour to \$0.08 per hour.

NOW, THEREFORE BE IT RESOLVED, the County of San Bernardino, Board of Supervisors' Chairman and Vice Chair affirms the full Board's approval of IHSS Public Authority's Public Authority and Non-Profit Consortium Rate Change Request (SOC 449) to be effective July 1, 2021, as signed below:
