RESOLUTION NO. 2021-063

RESOLUTION OF THE BOARD OF DIRECTORS OF THE BIG BEAR VALLEY RECREATION AND PARK DISTRICT, ESTABLISHING THE FISCAL YEAR 2020-2021 FINAL APPROPRIATIONS LIMIT

On Tuesday, May 4, 2021, on motion of Director Baca, Jr., duly seconded by Director Cook and carried, the following resolution is adopted by the Board of Directors of the Big Bear Valley Recreation and Park District.

WHEREAS, Article XIII B of the California State Constitution imposes a limitation on appropriations by local governmental entities; and

WHEREAS, the Board of Directors acted on June 23, 2020, to establish the fiscal year 2020-21 appropriations limit as required by Government Code Section 7910; and

WHEREAS, Proposition 111, as adopted by the voters on June 6, 1990, changed the manner of calculating the appropriations limit under Article XIII B of the California State Constitution; and

WHEREAS, Section 1 of Article XIII B of the California State Constitution generally provides that the total annual appropriations subject to limitation of the State and of each local government shall not exceed the appropriations limit of the entity of government for the prior year adjusted for the change in the cost of living and the change in population; and

WHEREAS, information has now become available to recalculate the appropriations limit for fiscal year 2020-21 in conformance with the options provided by Proposition 111; specifically, the options identified in Section 8(e)(2) of Article XIII B of the California State Constitution; and

WHEREAS, in determining "change in the cost of living" pursuant to section 8(e)(2) of Article XIII B of the California State Constitution, an entity of local government other than a school district or a community college district has the option to select either (A) the percentage change in the California per capita personal income from the preceding year, or (B) the percentage change in the local assessment roll from the preceding year due to the addition of local non-residential new construction; and

WHEREAS, the recalculation of appropriations limit for fiscal year 2020-21 is desirable in that this action will provide additional appropriations authority to continue operations at normal levels.

NOW, THEREFORE, BE IT RESOLVED, that the fiscal year 2020-21 appropriations limit established by the Board of Directors on June 23, 2020, is hereby amended to reflect the Big Bear Valley Recreation and Park District's selected option for determining the "change in the cost of living", as reflected in the report attached hereto as Attachment "A", and incorporated herein by this reference.

BE IT FURTHER RESOLVED that said Attachment "A" represents the fiscal year 2020-21 final appropriations limit and is hereby adopted by the Board of Directors.
