AMENDMENT NUMBER 1 TO THE BUSINESS RENTAL SHORT TERM PREFERRED RATE AGREEMENT BY AND BETWEEN <u>SAN BERNARDINO COUNTY REGISTRAR OF VOTERS</u> AND ENTERPRISE RENT-A-CAR

This Amendment, effective ________("Effective Date"), is attached to and made a part of the Business Rental Short Term Preferred Rate Agreement entered into on the <u>25th</u> day of <u>September</u>, <u>2020</u> (hereinafter the "Agreement") by and between Enterprise Rent-A-Car and <u>San Bernardino County Registrar of Voters</u> ("Customer"). This Amendment is made for good and valuable consideration, the receipt of which is hereby acknowledged by the parties.

The Parties wish to amend the Agreement to add a term regarding Cancelation Policy for the term of the Agreement.

The Agreement is hereby amended to include the following language:

Cancelation Policy

For the 2020 election specialty request for vans, the San Bernardino Registrar of Voters acknowledges a commitment to the cancelation policy below.

The "cancelation policy" for San Bernardino Registrar of Voters, for the specialty request for vans for use in the November 2020 Election is as follows:

- All cancelations must be made with 14 day notice before the scheduled delivery date.
- If notice is less than 14 days, a 1 week penalty per vehicle plus the delivery fee per vehicle will be charged.

The rates for rental of vans for the November 2020 Election shall be:

Weekly rate: Minivan- \$244.77/weekly rate Cargo/Passenger van- \$437.09/weekly rate

Delivery/seat removal fees: Minivan- \$250/van Cargo/Passenger van- \$550/van

The terms and conditions of the Agreement, except as duly modified by this and previous amendments, if any, remain in full force and effect.

Fuel Charges: Anytime a vehicle is returned with less fuel than it was rented with, the branch will charge Market Rate/Value for refueling.

Drop Charges: For rentals to Customer's employees for business use, there will be no drop charges for any vehicles that are picked up and returned at an alternative Rental Branch location within the US with the exception of New York (does not apply to Rent-A-Truck vehicles). This does not apply to any vehicles rented under personal rental benefit accounts.

CDW for Business Rentals: For rentals to Customer's employees for business use, Rental Rates include full CDW (Collision Damage Waiver) with no deductible. CDW will cover any physical damage to the vehicle that may occur during a rental and is subject to the terms and limitations set forth in Enterprise's standard rental contract.

SLP for Business Rentals: For rentals to Customer's employees for business use, Rental Rates include SLP (Supplemental Liability Protection). SLP will cover up to \$300,000 in liability claims that may occur during a rental, as the result of an accident, and is subject to the terms and limitations set forth in Enterprise's standard rental contract.

Terms of Contract: This Customer is participating in the CA Government Business Contract with Enterprise Rent-A-Car. This contract will be in effect through February 28, 2021.
