

**SRESOLUTION NO. 2021-80**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF  
SABERNARDINO, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE  
GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE R-22 (TWIN PEAKS),  
FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2021-22**

On Tuesday, June 8, 2021, on motion of Supervisor Rutherford, duly seconded by Supervisor Baca and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of County Service Area 70, Zone R-22, therefore, hereby finds and determines:

(a) That on July 16, 2002, the electors of County Service Area 70, Zone R-22, duly authorized a special tax levy for financing road maintenance services.

(b) That the amount of such tax was established at a not to exceed amount of \$217 per parcel for the first year, and \$100 per parcel each year thereafter.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of County Service Area 70, Zone R-22, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2021-22 shall be set at \$100 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective on July 1, 2021.
