

**RESOLUTION NO. 2021-85**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE R-5 (SUGARLOAF), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2021-22**

On Tuesday, June 8, 2021, on motion of Supervisor Rutherford, duly seconded by Supervisor Baca and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of County Service Area 70, Zone R-5, therefore, hereby finds and determines:

(a) That on May 1, 2007, the electors of County Service Area 70, Zone R-5, duly authorized a special tax levy for financing road maintenance services.

(b) That the amount of such tax shall be \$60.00 per parcel, with an annual 2.5% inflationary factor increase each year thereafter.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing board of County Service Area 70, Zone R-5, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2021-22 shall be set at \$84.80 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective on July 1, 2021.

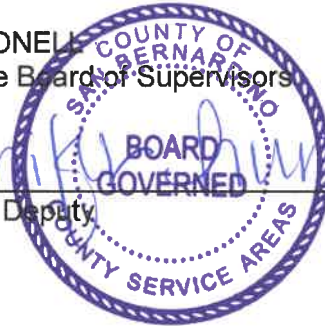

## **ATTACHMENT K**

Adopt Resolution setting a special tax for County Service Area 70, Zone R-5 (Sugarloaf) at \$84.80 per parcel, which includes the annual 2.5% inflationary factor increase.

**Background:** On May 1, 2007, the electorate of County Service Area 70, Zone R-5 (Sugarloaf) authorized an annual special tax of \$60 per parcel with an annual 2.5% inflationary factor increase for road maintenance services. There are 3,535 parcels within the district.

Funds generated by the special tax are used for ongoing asphalt road maintenance, street and stop sign maintenance, tree trimming, snow removal and cindering. The tax is anticipated to generate approximately \$299,768 for FY 2021-22, in relation to estimated total proposed appropriations of \$383,790.
