Amendment No. 11 to Contract 92-1023 with Live Nation Worldwide, Inc. to Extend the Contract Term Due to a Delay of Performance

RECOMMENDATION(S)

Approve **Amendment No. 11** to Revenue **Lease Agreement No. 92-1023** with Live Nation Worldwide, Inc. extending the contract expiration date from June 30, 2023 to June 30, 2024, with no change to the payment terms, due to a delay of performance caused by the Coronavirus pandemic.

COUNTY AND CHIEF EXECUTIVE OFFICER GOALS & OBJECTIVES

Operate in a Fiscally-Responsible and Business-Like Manner.

FINANCIAL IMPACT

Approval of this amendment does not require the use of additional Discretionary General Funding (Net County Cost). Pursuant to Amendment No. 11 to Contract No. 92-1023, Live Nation Worldwide, Inc. (Live Nation) will continue to pay an annual fixed minimum rent fee of \$1,400,000 or a percentage of net ticket sales rent, equal to 7.75% of net ticket sales, whichever is greater. Live Nation also agrees to pay 25% of the total "other revenue", which is defined as total gross revenue minus net ticket sales, when it exceeds the projected revenue for the designated lease year as set forth in the contract for the extended lease term through June 30, 2024. Additionally, Live Nation will continue to pay the Regional Parks Department (Department) \$1,500 per Electronic Dance Music (EDM) event for a maximum of four shows per year. While no lease payment will be received in 2020-21, adequate appropriation and revenue have been included in the Department's 2021-22 recommended budget and will be included in future recommended budgets.

BACKGROUND INFORMATION

The Department operates and maintains ten regional parks including Glen Helen Regional Park. This recommendation amends Contract No. 92-1023 with Live Nation extending the term of the contract by one year. In fiscal year 2020-21, Live Nation was unable to operate due the Coronavirus pandemic. They therefore requested a postponement of lease fees based on their inability to provide services as detailed in their lease, which resulted in a delay of performance. While lease fees will not be received during 2020-21, the contract will be extended one additional year and lease fees will be received for that extension period. This agreement aligns with the County and Chief Executive Officer's goal and objective to Operate in a Fiscally-Responsible and Business-Like Manner by enabling the Department to leverage its park

property resources to generate revenue, with the purpose of reducing reliance upon Discretionary General Funding.

Live Nation is the current operator of the amphitheater at Glen Helen Regional Park (Park) in accordance with Contract No. 92-1023, which was approved by the Board on October 19, 1992 (Item No. 59). This contract has been amended ten previous times as indicated in the table below:

8	61	January 29, 2013	Authorized four Electronic Dance Music (EDM) events per calendar year for a fee of \$1,500 per event.
9	53	March 3, 2015	Extended the term for naming rights effective retroactively from January 1, 2014 through December 31, 2017 for a total fee of \$240,000 for naming rights.
10	51	June 26, 2018	Extended the term of the contract through June 30, 2023 and required implementation of recommendations made by the Electronic Dance Music Task Force.
