IN THAT CERTAIN **Contract No. 19-240** by and between the County of San Bernardino, a political subdivision of the State of California, and Contractor for the provision of Substance Use Disorder Narcotic Treatment Program Services, which contract first became effective July 1, 2019, the contract is hereby amended as follows, effective June 8, 2021:
