THIS CONTRACT is entered into in the State of California by and between the County of San Bernardino, hereinafter called the County, and High Desert Child, Adolescent and Family Services Center, Inc. referenced above, hereinafter called Contractor.

**IT IS HEREBY AGREED AS FOLLOWS:****WITNESSETH:**

IN THAT CERTAIN **Contract No. 17-333** by and between the County of San Bernardino, a political subdivision of the State of California, and Contractor for the provision of Substance Use Disorder Services Outpatient Treatment and Intensive Outpatient Treatment Services, which contract first became effective July 1, 2017, the contract is hereby amended as follows, effective July 1, 2021:

I. ARTICLE IV FUNDING paragraph K is hereby amended to read as follows:

K. The contract amendment amount of \$458,149 shall increase the total contract amount from \$1,832,597 to \$2,290,746 for the contract term. Separately, there is an additional aggregate funding amount of \$891,352 that may be applied (but not necessarily ensured) for any client referred from San Bernardino County Children and Family Services.

II. ARTICLE XIV DURATION AND TERMINATION, paragraph A is hereby amended to read as follows:

A. The term of this Agreement shall be from July 1, 2017 through June 30, 2022 inclusive.

- III. This amendment hereby replaces Schedules A and B for FY 2021/22. All previously approved schedules remain in effect. The revised Schedules A and B will be submitted to, and approved by, the Director or designee at a later date.
- IV. All other terms, conditions and covenants in the basic agreement remain in full force and effect.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.






