IN THAT CERTAIN **Contract No. 17-334** by and between the County of San Bernardino, a political subdivision of the State of California, and Contractor for the provision of Substance Use Disorder Services Outpatient Treatment and Intensive Outpatient Treatment Services, which contract first became effective July 1, 2017, the contract is hereby amended as follows, effective July 1, 2021:

- I. ARTICLE IV <u>FUNDING</u>, paragraph K is hereby amended to read as follows:
 - K. The contract amendment amount of \$337,190 shall increase the total contract amount from \$1,348,760 to \$1,685,950 for the contract term. Separately, there is an additional aggregate funding amount of \$891,352 that may be applied (but not necessarily ensured) for any client referred from San Bernardino County Children and Family Services.
- II. ARTICLE XIV <u>DURATION AND TERMINATION</u>, paragraph A is hereby amended to read as follows:
 - A. The term of this Agreement shall be from July 1, 2017 through June 30, 2022 inclusive.
