**Amendment 2 to the  
Product Specific Terms – Schedule 2  
under the Elsevier Master Agreement**

This Second Amendment (“Amendment 2”) to the Product Specific Terms – Schedule (“Schedule 2”) of the Elsevier Master Agreement dated, and all subsequent amendments thereto (the “Agreement”) is entered into on December 1, 2021 (“Amendment Effective Date”) by and between **County of San Bernardino on behalf of Arrowhead Regional Medical Center**, 400 N. Pepper Avenue, Colton, CA 92324, USA (“Client”), and **Elsevier Inc.**, 1600 John F Kennedy Blvd, Suite 1800, Philadelphia, PA 19103, USA (“Elsevier”).

**WHEREAS**, the Parties wish to amend Schedule 2 in order to extend the term and revise the fees as described herein.

**NOW, THEREFORE**, in consideration of the mutual covenants contained herein and in Schedule 2 and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree to amend Schedule 2 as follows:

1. Section 10. Term. is hereby extended through November 30, 2024.
2. Section 12. Sites/Facilities is hereby deleted in its entirety and amended as follows:

Arrowhead Regional Medical Center – 400 North Pepper Avenue, Colton, CA 92324  
Arrowhead Family Health Center – Fontana, 16854 Ivy Avenue, Fontana, CA 92335  
Arrowhead Family Health Center – McKee, 1499 E. Highland Avenue, San Bernardino, CA 92404  
Arrowhead Family Health Center – Redlands, 800 East Lugonia Avenue, Suite F, Redlands, CA 92374  
Arrowhead Family Health Center – Westside, 850 East Foothill Boulevard, Rialto, CA 92376

Client shall promptly notify Elsevier of any increase in the number of sites or facilities. In the event that additional sites or facilities other than those listed above are added, the Fees shall be subject to an increase in the then applicable Fees in accordance with Section 14 and Annex A, effective as of the date such additional sites or facilities were added and payable within sixty (60) days of Elsevier’s invoice.

3. As of the Amendment Effective Date, Annex A to Schedule 2 is hereby amended to include Annex A to Amendment 2, attached hereto.
4. The new pricing provided in Annex A, attached hereto, will apply to the renewal term beginning December 1, 2021 through November 30, 2024.
5. Notwithstanding anything to the contrary set forth in this Amendment 2, in the event of a conflict between the terms of Schedule 2 and the terms of this Amendment 2, this Amendment 2 shall control. Other than as specifically modified by this Amendment 2, all of the other terms and conditions of Schedule 2 shall continue to be in full force and effect. Unless otherwise defined herein, capitalized terms shall have the meanings given such terms in Schedule 2.
6. This Amendment 2 may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. The parties shall be entitled to sign and transmit an electronic signature of this Amendment 2 (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment 2 upon request.

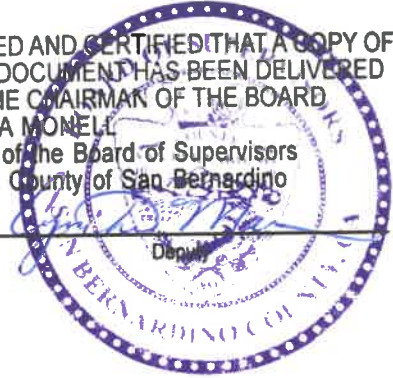
