Delete and replace Attachment C - Pricing Sheet with the Pricing Sheet attached hereto as Exhibit 1.

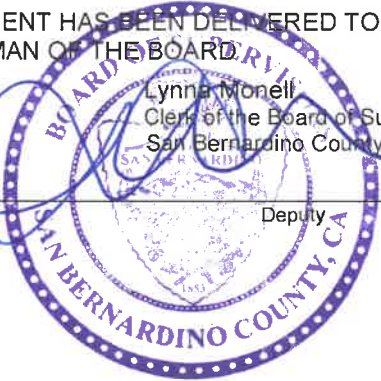
