AMENDMENT NO. 1

This Amendment No. 1 (this "Amendment"), effective July 27, 2021, is made by and between ZIMMER US, INC dba ZIMMER BIOMET and SAN BERNARDINO COUNTY (collectively, referred to as the "Parties") and modifies the terms of the Contract fully executed between the Parties on July 14, 2020 as follows:

1. Section F.1 of the Contract is deleted in its entirety and replaced with the following:
 - F.1 The maximum amount of payment under this Contract shall not exceed \$900,000 for the term of this Contract, which may be federally funded, and shall be subject to availability of other funds to the County. County shall not place orders for products if the amount exceeds \$900,000. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's products provided in the performance hereof.
2. **Full Force and Effect.** All other terms and conditions of the Contract remain in full force and effect.
3. **Capitalized Terms.** Any capitalized term used but not defined in this Amendment shall have the meaning given to it in the Contract.
4. **Counterparts.** This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this

Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
