### Expectations of Participation Sites



- Identify a core team of up to 3 – 4 members representing different roles (e.g., leadership and clinicians) from both the primary care clinic and community partner
- Designate one point person to manage team's participation
- Create, implement, and measure a plan for improving depression care and strengthening the partnership
- Actively participate in the 12-month learning collaborative activities (see below)
- Complete a short online survey in June 2022 reflecting on your experience and progress toward learning collaborative goals

- Four webinars on evidence-based depression care and partnership building: August and September 2021
- Two day virtual meeting, October 7, 2021 and October 8, 2021, 9am -12pm Pacific
