My family owns 2 homes, we are full time residents.

I am against granting a Conditional Use Permit for Pine Rose Cabins without assigning conditions to mitigate the excessive noise. Pine Rose has large gatherings near our houses and operates a PA with amplified music that is VERY LOUD- it echoes down the canyon behind our houses and is heard inside with the doors and windows closed!

We cherish our quiet surroundings, Pine Rose events are too loud, and should not be allowed to continue operations without addressing the impacts that their events have on people living nearby.

The resort should reduce its maximum occupancy and install a sound barrier or enclose the outdoor gathering site to reduce the noise from the sound system/guests; limit their event days so that neighbors can have time without party noise and crowds- weekends should be considered also. Amplified DJ's are too loud for this location- the sound goes over my TV. A full-time event security guard should be on duty to monitor afterhours partying/drinking/screaming/yelling.

STR's are now being scrutinized because they can have a negative impact on our communities and quality of life- planners are tasked with finding solutions to reduce those impacts. Excessive noise is a very real concern; finding a reasonable solution to this problem will help prevent future disagreements.
