This AMENDMENT NO. 2 TO THE EMERGENCY OCCUPANCY AGREEMENT (Agreement) is entered into for the period effective January 1, 2021 to June 30, 2022 by and between SAN BERNARDINO COUNTY (County) and Orange Show Hospitality, Inc. (Owner).

IT IS HEREBY AGREED AS FOLLOWS:

The Agreement by and between San Bernardino County, a political subdivision of the State of California, and Owner for the provision of Emergency Occupancy, is hereby amended effective October 1, 2021 to extend the term of the contract through June 30, 2022 and as follows:

- I. Paragraph 3 is hereby deleted and replaced as follows:
 - 3. The term of this Agreement shall commence on January 1, 2021, and shall continue through June 30, 2022, with such rights of termination as may be hereinafter expressly set forth. Should notice of termination not be given the Agreement shall continue on a month to month basis on the same terms and conditions subject to the right of termination.
- II. Paragraph 5 is hereby deleted and replaced as follows:
 - 5. Payments shall be paid by the County, from legally available funds and subject to California laws. The maximum amount of payment under this Contract shall not exceed \$1,787,202. Rental payments are invoiced monthly and shall be paid by the 15th day following the receipt of a non-disputed invoice. Allowable rates during said term are as follows:

Daily rate per room: \$106.94 (inclusive of hotel occupancy tax)



Payments shall only be made on the number of occupied rooms. Payments shall be paid to the Owner at the address specified in Paragraph 6. Owner shall invoice County at 30-day increments with all details County requires as specified in Exhibit D.

Last room availability – upon execution of this Contract, the County holds a Last Room Availability which guarantees the County the right to occupy a room under the contracted terms aforementioned.
