Project Description

Project Title: The Redwood Ave. and Other Roads Project.

Project Location: The Proposed Project is planned for Redwood Avenue; Live Oak Avenue; Elm Avenue; Hawthorne Avenue; Hibiscus Avenue; Poplar Avenue and Hunter Street. This project area is about 1.5-miles north of I-10 Freeway and 3.5-miles east of I-15, in the unincorporated area of Fontana, San Bernardino County, California. (see attached Regional/Vicinity Map and Location Map).

Project Description: The proposed Project entails grinding (milling) and removing about a half an inch of the existing asphalt concrete road surface; then applying a leveling course of new asphalt concrete. The approximate dimensions of the mill and overlay are 60-feet wide and a total length of about 5.03 miles. Equipment to be used includes but is not limited to: Cold Planer, Concrete Mixer, Backhoe, Paver, Roller and Loader Truck (for removed concrete) and Water Truck.
