IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 1

WITNESSETH:

IN THAT CERTAIN: Contract No. 16-793 by and between the County of San Bernardino, now known as San Bernardino County ("County") and Five Keys Schools and Programs ("Contractor") for providing Education Services to adult offenders at County operated Day Reporting Centers, which first became effective October 4, 2016, the following changes are hereby made and agreed effective October 1, 2021:

I. SECTION J. TERM OF CONTRACT is hereby amended to read as follows:

This Contract is effective as of October 4, 2016 and expires December 31, 2021, but may be terminated earlier in accordance with provisions of this Contract.

II. SECTION L. ELECTRONIC SIGNATURE is hereby added to read as follows:

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The Parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein.

Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

III. Replace all references in the Contract to County from County of San Bernardino to San Bernardino County.

IV. All other terms, conditions, and covenants in Contract No. 16-793 remain in full force and effect.
