AMENDMENT NO. 3:

It is hereby agreed to amend Contract No. 19-729, effective November 1, 2021, as follows:

SECTION VI. FISCAL PROVISIONS

Amend Paragraph A to read as follows:


- A. The maximum amount of reimbursement under this Contract shall not exceed \$500,000 in Fiscal Year (FY) 2019-20, \$112,500 in FY 2020-21, \$84,400 in FY 2021-22, and \$84,400 in FY 2022-23, for a total contract amount not to exceed \$781,300, and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

All other terms and conditions of Contract No. 19-729 remain in full force and effect.




