RESOLUTION OF THE BOARD OF SUPERVISORS FOR THE APPROVAL OF THE PUBLIC AUTHORITY AND NON-PROFIT CONSORTIUM RATE CHANGE REQUEST TO THE CALIFORNIA DEPARTMENT OF SOCIAL SERVICES FOR IN-HOME SUPPORTIVE SERVICES PROVIDER WAGES

On Tuesday October 5, 2021, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Cook and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the In-Home Supportive Services (IHSS) Public Authority was establish by San Bernardino County through Ordinance No. 3842 to act as the employer for San Bernardino IHSS providers pursuant to Welfare and Institutions Code section 12301.6, subdivision (c)(1), and to perform other IHSS functions as required by Welfare and Institutions Code section 12301.6, subdivision (e) and not retained by the County.

WHEREAS, pursuant to Senate Bill 3, which amended 1182.12 of the California Labor Code, which increased the minimum wage for all industries to \$15 per hour effective January 1, 2022, and California Health and Human Services Agency, Department of Social Services (CDSS) Information Notice No. I-64-21, IHSS Public Authority must submit a Public Authority and Non-Profit Consortium Rate Change Request (SOC 449) to be compliant with the new minimum wage requirement for IHSS providers.

WHEREAS, CDSS requires San Bernardino County, Board of Supervisors to approve IHSS Public Authority's Public Authority and Non-Profit Consortium Rate Change Request (SOC 449) updating the Public Authority and Non-Profit Consortium rate pertaining to In-Home Supportive Services Provider wages and benefits, for a total increase of \$1.08 per hour, from \$16.11 per hour to \$17.19 per hour, effective January 1, 2022, as specified below:

- a. Hourly wage (non-locally negotiated, state minimum wage) increase of \$1.00 per hour, from \$14.00 per hour to \$15.00 per hour.
- b. Payroll Tax increase of \$0.08 per hour, from \$1.20 per hour to \$1.28 per hour.

NOW, THEREFORE BE IT RESOLVED, San Bernardino County, Board of Supervisors' Chairman and Vice Chair affirms the full Board's approval of IHSS Public Authority's Public Authority and Non-Profit Consortium Rate Change Request (SOC 449) to be effective January 1, 2022, as signed below:
