## AMENDMENT NO. 4 TO MEMBER AGREEMENT LETTER

WHEREAS, Vizient Supply, LLC's ("Vizient") predecessor, Novation, LLC and Language Services Associates ("LSA") entered into a Supplier Services Agreement ("Supplier Agreement") for language interpretation services with an effective date of May 1, 2014 and an initial term of three (3) years, which automatically renewed for two (2) additional one year terms; and

WHEREAS, Vizient and LSA entered into an Amendment to the Supplier Agreement with an effective date of May 1, 2019 that extended the term of the Supplier Agreement to April 30, 2020; and

WHEREAS, Vizient and LSA entered into an Amendment to the Supplier Agreement with an effective date of April 30, 2020 which extended the term of the Supplier Agreement to April 30, 2021; and

WHEREAS, San Bernardino County on behalf of Arrowhead Regional Medical Center ("County") is a member of Vizient and is entitled to access certain group purchasing opportunities procured by Vizient for its members; and

WHEREAS, the County entered into a Member Agreement Letter with LSA in 2015 to obtain the language interpretation services of LSA under the Supplier Agreement.

WHEREAS, recognizing that Vizient and LSA entered into an Amendment to the Supplier Agreement to extend the term of the Supplier Agreement to April 20, 2021, County and LSA entered into an Amendment to the Member Agreement Letter on or about May 25, 2020, affirming the continued force and effect of the Supplier Agreement and County's ability to access LSA's services under the Supplier Agreement.

WHEREAS, Vizient and LSA entered into an Amendment to the Supplier Agreement with an effective date of April 30, 2021 which further extended the term of the Supplier Agreement to April 30, 2022.

WHEREAS, on or about April 6, 2021, County and LSA entered into an Amendment to the Member Agreement Letter to further extend the term through October 31, 2021 with no other changes to the terms and conditions.

WHEREAS, as a result of the extension of the term of the Supplier Agreement, County and LSA now seek to amend the Member Agreement Letter to set a not-to-exceed total contract amount of \$2,850,000 and to extend the term through April 30, 2022.

THEREFORE, the County and LSA mutually agree to amend the terms of the Member Agreement Letter as follows, effective as of the last date this Amendment No. 4 is executed by the parties:

1. Add the following provision to the Member Letter Agreement:

"The not-to-exceed total contract amount is \$2,850,000."

- 2. The term is extended through April 30, 2022.
- 3. All other terms and conditions of the Member Letter Agreement, as previously amended by the parties, shall remain in full force and effect.
- 4. This Amendment No. 4 may be executed in any number of counterparts, each of which so executed be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
