## **AMENDMENT NO. 1**

WHEREAS, County of San Bernardino ("County") and SOLID Surface Care, Inc. ("Contractor") entered into a services agreement ("Contract"), fully executed by the parties on December 2, 2019, with a term of November 1, 2019 through May 31, 2024; for the provision of deep cleaning services for Arrowhead Regional Medical Center ("ARMC");

WHEREAS, as a result of the COVID-19 pandemic, the County requires additional deep cleaning services from the Contractor for ARMC;

THEREFORE, effective as of the date this Amendment No. 1 is fully executed by the parties, the parties agree to amend the Contract as follows:

- 1. Delete Section E.1 of the Contract in its entirety and replace with the following:
  - E.1 Contractor will be reimbursed on a fee for service basis in accordance with rates listed in Attachment A. The total amount of payments under this Contract shall not exceed \$1,873,000.
- 2. All other terms and conditions of the Contract shall remain in full force and effect.
- 3. This Amendment No. 1 may be executed in any number of counterparts, each of which so executed be deemed to be an original, and such counterparts shall together constitute one and the same Amendment.
