AMENDMENT NO. 1

San Bernardino County on behalf of Arrowhead Regional Medical Center and CEP America – California hereby amend Agreement No. 20-1199 in the following manner, effective as of the date this Amendment No. 1 is fully executed:

- 1. All references to "County of San Bernardino" are amended to read as "San Bernardino County."
- 2. Amend the header of Part III, Subpart *D* Duties of Corporation at San Bernardino County Fire Protection District to read as follows:

E. DUTIES OF CORPORATION AT SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT

3. Delete the entirety of Part III, Subpart D. Duties of Corporation at San Bernardino County Department of Behavioral Health – Alcohol and Drug Services and replace with the following:

D. DUTIES OF CORPORATION AT SAN BERNARDINO COUNTY DEPARTMENT OF BEHAVIORAL HEALTH - ALCOHOL AND DRUG SERVICES

3.33 <u>Obligations at the San Bernardino County Department of Behavioral Health – Substance Use</u> Disorder and Recovery Services

Corporation shall provide to the Department of Behavioral Health – Substance Use Disorder and Recovery Services (hereinafter referred to as DBH-SUDRS) the services of up to 1.0 FTE qualified Practitioners for the term of this Contract. The duties of the Practitioners at DBH-SUDRS shall be mutually agreed upon by Corporation and DBH Director and will, at a minimum, include the responsibilities set forth in Part III, Subpart D. It shall be the responsibility of the Corporation to provide the services under the terms and conditions set forth in this Part III, Subpart D. Upon approval of the Medical Director of DBH, a APP (Nurse Practitioner or Physician Assistant) may be substituted for a physician with compensation at 75 percent of the physician rate.

3.34 Medical Services

Corporation shall designate three (3) psychiatrists who will be assigned to the DBH-Medical Services (hereinafter referred to as DBH-MS) on a full-time basis and will have responsibility for the psychiatric provisions of the Mental Health services provided at DBH. Unless otherwise agreed upon by the Director of DBH and Corporation, the specific psychiatrists and total minimum annual hours of services to be provided by each psychiatrist under this provision of the Agreement is as follows:

Administrative Responsibilities

- a. Collaborate with DBH-SUDRS and/or DBH-MS to plan and develop health services in the clinics.
- b. Ensure Practitioner's services are being provided in accordance with Title 22 California Code of Regulations 51341.1, when applicable.
- c. Review and approve policies and procedures in coordination with DBH-SUDRS and/or DBH-MS.
- d. Review and approve standardized procedures at DBH-SUDRS and/or DBH-MS.
- e. Assist and participate in Clinic Case Review meetings to discuss patient's progress in treatment and provide recommendations, as necessary.
- f. Meet on a regular basis with other County physicians at Hospital, Department of Public Health, and DBH and any other health care providers to discuss common medical issues and conduct peer review.
- g. Participate in Health Education programs for clients and staff at DBH.

- h. Arrange for annual peer review, or other peer review required hereunder at DBH.
- i. Review the Drug Medi-Cal and Medi-Cal Formulary at least annually; actively participate on quarterly Pharmacy & Therapeutics meetings.
- j. Pursuant to HIPAA and 42 CFR Part 2, DBH has implemented administrative, physical, and technical safeguards to protect the confidentiality, integrity, and availability of protected health information (PHI) transmitted or maintained in any form or medium.
- k. Should Corporation require the need to obtain PHI of a DBH client, Corporation must follow appropriate methods of obtaining authorization to access PHI. This includes through a valid court order or subpoena or a signed Authorization for Release of PHI (this form can be obtained by DBH and is located on the DBH website forms index).
- I. Regulations have been promulgated governing the privacy and security of individually identifiable health information (IIHI), PHI and electronic Protected Health Information (ePHI). DBH has a specific responsibility to comply with all applicable State and Federal regulations pertaining to privacy and security of client PHI and strictly maintain the confidentiality of behavioral health records, in accordance with HIPAA, WIC 5328 and 42 CFR Part 2. All parties shall ensure any DBH client PHI that is stored on its premises will be locked and secure in adherence to IIHI and PHI privacy requirements.
- m. In addition to the aforementioned protection of IIHI, PHI and e-PHI, all parties shall adhere to the protection of personally identifiable information (PII) and Medi-Cal PII. PII includes any information that can be used to search for or identify individuals such as but not limited to name, social security number or date of birth. Medi-Cal PII is the information that is directly obtained in the course of performing an administrative function on behalf of Medi-Cal, such as determining eligibility, that can be used alone or in conjunction with any other information to identify an individual.
- n. Reporting Improper Access, Use, or Disclosure of Unsecure PHI and PII. Upon discovery of any unauthorized use, access or disclosure of PHI or any other security incident with regards to DBH PHI or PII, all parties agree to report to DBH no later than one (1) business day upon the discovery of a potential breach. All parties shall provide information to DBH to assist with appropriate reporting requirements to the DBH Office of Compliance.

Clinical Activities

o. Provide medical consultation for any patients who present a physical health concern while seeking treatment or during a treatment episode.

Physical Examination Requirements (DBH-SUDRS):

- a. If a patient has a physical examination within the twelve (12) month period prior to the patient's admission to treatment date, Practitioner shall review documentation of the patient's most recent physical examination within thirty (30) calendar days of the patient's admission to treatment date. If the SUD Clinic is unable to obtain documentation of a patient's most recent physical examination, the SUD Clinic shall describe the efforts made to obtain this documentation in the patient's individual patient record.
- b. As an alternative to complying with paragraph (a) or in addition to complying with Paragraph (a) above, the physician, a registered nurse practitioner, or a

- physician's assistant may perform a physical examination of the patient within thirty (30) calendar days of the patient's admission to treatment date.
- c. If the physician has not reviewed the documentation of the patient's physical examination as provided for in Paragraph (a) or the physician does not perform a physical examination of the patient as provided for in Paragraph (b), then the SUD Clinic shall include in the patient's initial and updated treatment plans the goal of obtaining a physical examination, until this goal has been met.

Treatment Plan Requirements:

- 1. The designated Practitioner shall review the initial treatment plan to determine whether the services are medically necessary.
 - i. For DBH-SUDRS, this determination shall be consistent with Title 22 CCR Section 51303. If the Practitioner determines the services in the initial treatment plan are medically necessary, the Practitioner shall type or legibly print their name, and sign and date the treatment plan within fifteen (15) calendar days of signature by the therapist or counselor.
- 2. The Practitioner shall review each updated treatment plan to determine whether the services are medically necessary.
 - i. For DBH-SUDRS, this determination shall be consistent with Title 22 CCR Section 51303. If the Practitioner determines the services in the updated treatment plan are medically necessary, the Practitioner shall type or legibly print their name, and sign and date the updated treatment plan, within fifteen (15) calendar days of signature by the therapist or counselor. If the Practitioner has not prescribed medication, a psychologist licensed by the State of California Board of Psychology may review for medical necessity, type or legibly print their name and sign and date an updated treatment plan.
- p. Maintain responsibility for evaluating patient's medical history and physical condition; provide and document the diagnosis (DSM Code) that is utilized to assist in establishing patient's medical necessity for treatment.
- q. Provide an assessment of patient's treatment need based on established medical necessity.
- r. For DBH-SUDRS, the Practitioner is the only individual who can waive, based on a clinical determination of the patient, minimum participation requirements in treatment.
- s. For DBH-SUDRS, determine medical necessity for patients for continued services every six (6) months.
- t. Provide limited Medication Assisted Treatment (MAT) as deemed medically necessary.
- u. Provide all appropriate documentation for treatment services and billing purposes.
- v. Provide to DBH for its approval all monthly timesheets of Practitioners providing services to DBH
- w. Other outpatient duties as assigned by the Department of Behavioral Health

3.35 Time and Attendance

Corporation shall be responsible for time and attendance accountability and provide appropriate records to DBH upon demand.
