- 1) 1. Provide direction and guidance regarding the State recommendation to counties on the County Monitoring List to close bars, pubs, brew pubs and breweries (unless offering sit-down, dine-in meals) until those establishments are allowed to resume operation per

State guidance in order to slow the community spread of COVID-19.

2. Provide direction on proactive measures to encourage compliance by all entities or establishments with orders and guidelines from federal, state and local authorities in order to slow the community spread of COVID-19.

The Board provided the following guidance:

1. The Board expressed a strong desire to maintain local control. They advised staff to see what numbers look like on Friday, July 3, and prepare Health Order to close establishments if necessary so County could re-open with a new Health Order when COVID-19 numbers drop.
2. The Board wished to implement a strong education process to get non-compliant businesses to become compliant in collaboration with cities to help educate businesses; if businesses are still not compliant, refer them to County.
3. The Board asked to reward good actors and help businesses to comply and maintain compliance; including the possibility of using COVID-19 funding to pay for modifications.
4. The Board stated the need to possibly respond further based on the Governor's upcoming actions and guidance.
